

DECLARATION OF WEEE CONFORMITY

ACCORDING TO THE PROVISIONS OF DECREE 2005-829 OF 29 JULY 2005-**WEEE**

Regulatory Context:

The 2 european directives:

- 2011/65/CE relative to the limitation of use of dangerous substances in electric and electronic equipments (called RoHS Directive)
- 2012/19/UE relative to the waste of electric and electronic equipments (called WEEE)

Have been transposed in France par the decrees:

- 2014-928 of 19 August 2014 relative on waste electrical and electronic equipment and used electrical and electronic equipment
- 2013-988 of 6 November 2013 relative to the restriction of the use of certain hazardous substances in electrical and electronic equipment
- 2012-617 of 4 May 2012 relative to the content of electric and electronic equipments and the elimination of their waste.

As manufacturer of such equipment, ECRIN SYSTEMS has to comply with those directives. This document describes what the company has put in place in order to comply with those directives.

1) Conception of the products

The standard specifications of ECRIN SYSTEMS regarding conception in regards to recycling ensure that conception and manufacturing of electronic equipments under the label of ECRIN SYSTEMS take into account the dismantlement and recycling of components and materials in regards to the end of life of those equipments.


2) Limitation of the use of some dangerous substances

ECRIN SYSTEMS assures that its products conform to RoHS Directive, which limits the use, in electric and electronic equipments, of lead, mercury, cadmium, hexavalent chromium, PBB (polybrominated biphenyl and PBDE (polybrominated diphenyl ether). Starting 1st July 2006 all products ECRIN SYSTEMS concerned by RoHS directive do not contain those substances, except the special case mentioned in the decree, where no alternative can be used.

3) Labelling of the products

All products ECRIN SYSTEMS sujet to the decree WEEE shipped by ECRIN SYSTEMS from his office of Crolles (38) starting 1st July 2006 conform to the labelling requirements of the decree. Those products are labelled with the official symbol representing a trash, as below, conforming to the European standard EN50419.

4) Professional WEEE professionnels

ECRIN SYSTEMS will manage the recycling of its professional equipment's sold after the 1st July 2006, when they will be EOL'd on its customer's site in France.

Costs of those recycling operations are included in the pricing of the products. Cost of gathering those wastes inside customers site are not included in standard pricing of ECRIN SYSTEMS.

5) Processing operations

In accordance with European regulation, ECRIN SYSTEMS confirms that recycling and processing of WEEE done under ECRIN SYSTEMS request, are managed in conformity with french regulation in regards to WEEE, particularly regarding processing of electronic components.
